
ADVOCACY

The Latino Caucus Board of Directors meets every January to set our policy priorities for the year. Our priorities guide our educational programming and legislative advocacy efforts.

This year the Latino Caucus prioritized its partnership with the California Latino Legislative Caucus to better advocate for these and future priorities.

This past year, the Latino Caucus also developed its relationship with several federal legislators during the National League of Cities conference in Washington, D.C. With this investment in partnerships, the Latino Caucus strives to serve our members and community better.









ADVOCACY



Housing Affordability

- Secure funding to increase the supply and affordability of housing. Secure adequate and sustainable funding for cities to increase the construction of housing at all income levels, particularly affordable housing and workforce housing.
- Advocate for the equitable distribution and comprehensive technical assistance of state and federal funding to address housing affordability in California cities.

Infrastructure

- Attain investments to strengthen and sustain critical infrastructure.
- Advocate for policies that strengthen the conditions of local streets, highways, bridges, public transit, and broadband to improve workforce and economic development.
- Secure support and work with stakeholders to provide cities with access to the tools needed to ensure projects are delivered equitably, efficiently, and costeffectively to meet current and future needs.

Climate Change

- Advance programs and policies addressing climate change, promote green technologies, and create new jobs and workforce opportunities.
- Advance California's climate goals by investing in the needs of the most polluted and underserved communities and by promoting the affordability, access, and equitable distribution of infrastructure resources for zero-emission mobility.

Immigration

- Promote federal comprehensive immigration reform legislation that provides a pathway to citizenship for undocumented residents.
- Expand naturalization services to provide education, outreach, and application assistance for lawful permanent residents and individuals eligible for administrative relief.
- Ensure access to quality and affordable health care for all Californians irrespective of immigration status.

Strategic Goal: To ensure Latinos, which were hardest hit by the effects of COVID-19, are provided the education and resources to endure and recover.



CENSUS 2020 COMPLETE COUNT-HARD TO COUNT COMMUNITIES

The Latino Caucus successfully launched a Census 2020 Complete Count social media campaign to increase the participation of our hard-to-count communities

Utilizing the expertise of our partners at the Census Bureau and our partners at NALEO, we provided timely and critical bilingual messaging to California. We also provided media toolkits to our members and partners with multilingual information and access to informational hotlines, spreading the word regarding hard-to-count communities and how to reach them.

We conducted a community event in Salinas, California, to provide education and tools to community leaders with their hard-to-count population.





LATINO LEADERSHIP PIPELINE

The Latino Caucus was founded thirty-plus years ago to bring together Latino leaders seeking connection with similar goals and experiencing similar challenges.

As we have grown in numbers and success, we feel deeply responsible to future Latino leaders. Therefore, we seek to pass on our shared history, provide mentorship, develop their advocacy and leadership skills, and expand their access to leadership opportunities.

We do this because we know that California's leaders whose ideas are diverse, whose perspectives are varied, and who feel valued are leaders who will ensure equity and inclusion for all Californians.

LATINO LEADERSHIP PIPELINE

Part of our effort in increasing the number of Latinos in leadership positions was researching procedural methods for applying for leadership positions and identifying potential barriers.

Demystifying the Governor's appointment process was one such example.

We also identified open positions within the National League of Cities and Cal Cities and encouraged our members to apply multiple times throughout the year.

Our most significant achievement to date was the collaborative work that successfully created a seat on the Cal Cities Board of Directors for each of the Caucuses. This monumental accomplishment was executed with the tireless leadership and diligence of former Latino Caucus President Roberto Uranga from the City of Long Beach, Latino Caucus legal counsel Bonny Garcia, Executive Director Emeritus John Arriaga, the African American Caucus, LGBTQ Caucus, API Caucus, Women's Caucus, and the entire Cal Cities leadership team.





LCCLC GOVERNANCE AND VISIBILITY

The Latino Caucus successfully rebranded and expanded our communications methods. We updated our website to increase usability for our members and partners. In addition, we updated our logo and branding.

In 2022 the Latino Caucus successfully updated our mission statement to reflect a more concise and action-oriented identity that we have developed over the years. Our goal will continue to evolve with changing technology and communication methods to remain accessible to our current and future members and partners.

COVID-19, LATINO RECOVERY
